

INTERNET SAFETY FOR FAMILIES

Recent news reports have caused great concern for parents of children using the Internet. While the Internet can be a great place for learning, researching and even socializing, there are precautions that parents should make their children aware of. The Internet has great resources for families interested in learning more about online safety and real risks to our children. ***Keep in mind that parenting your children in the cyber world is the same as parenting them in the real world.*** The easiest ways to keep your children safe, and your computer free from viruses and objectionable material are:

1. Know what your children are viewing online by keeping the computer in a family room or common area.
2. Become cyber savvy by bringing yourself up to speed on computer use.
3. Let kids know what Internet usage rules your family follows, and any behaviors you find unacceptable.
4. Have consequences in place if family rules on Internet use are violated.

We still have the better judgment. We have to make sure that we teach them to be trustworthy, and how to avoid dangers posed by others."

As parents, we each teach our children how to make responsible decisions. We need to recognize that ***their technology skills far outdistance their judgment.*** It's our job, as parents, to fill this gap with our greater experience and judgment. (No one ever said parenting was easy.) Bottom line: It's not your kids you have to distrust; it's the millions of others online. We have to arm our children with the skills they need to stay safe in this environment, while still enjoying it.

Remember: You are still the parent. The Internet hasn't changed that.

STAYING SAFE ONLINE: AN INTERNET CONTRACT

You can create a different contract for each child in your family with Internet usage rules set appropriately by age. Everyone signs his or her contract to show that they understand the rules and they agree to follow them when they go online.

I will ALWAYS tell a parent or another adult immediately if something is confusing or seemed scary or threatening.

I will NEVER give out my full name, real address, telephone number, school name or location, schedule, password, or other identifying information when I'm online. I will check with an adult for any exceptions.

I will NEVER have a face-to-face meeting with someone I've met online. In rare cases, my parents may decide it's Ok, but if I do decide to meet a cyber pal, I will make sure we meet in a public place and that a parent or guardian is with me.

I will NEVER respond online to any messages that use bad words or words that are scary, threatening, or just feel weird. If I get that kind of message, I'll print it out and tell an adult immediately. The adult can then contact the online service or appropriate agency. If I'm uncomfortable in a live chat room, I will use the "ignore" button.

I will NEVER go into a new online area that is going to cost additional money without first asking permission from my parent or teacher.

I will NEVER send a picture over the Internet or via regular mail to anyone without my parent's permission.

I will NOT give out a credit card number online without my parent present.
